# AU Forward: Spring 2022 Health and Safety Plan

For a safe and productive in-person semester, American Universit has updated our health and safet protocols. Important measures that all communit members must follow are outlined below.

# **Key Protocols**

#### Masking

All students, facult , sta , contract workers, and visitors, whether vaccinated or unvaccinated against COVID-19, are required to wear masks while indoors on universit propert .

Individuals are e pected to wear N95 or KN95 masks to ensure the highest level of protection. KN95 masks are available to students, facult, and sta with an AU ID at communit distribution points. An updated listing of these locations and hours can be found in <u>COVID Guide: Mask Distribution at AU</u>.

e onl e ceptions are when eating/drinking or alone in a private o ce. In residence halls, roommates in their rooms do not have to mask as the room is considered a famil dwelling. It is encouraged that roommates discuss masking upon move-in.

In classrooms, students must wear masks. Facult ma unmask if there is at least 3 feet distance between them and students.

Masks are not required outdoors unless in crowded places or groups of 25 people or more.

## Vaccinations

American Universit requires COVID-19 vaccinations for all students, facult, sta, contractors, and visitors. AU Communit members seeking an e emption for medical or religious reasons must complete the <u>Vaccination E emption Form</u> located on the AU Forward Portal and receive approval before an e emption is considered nal.

#### **Boosters**

All students, facult, and sta (whether full-time or part-time, on-campus, online, or h brid) are required to get a COVID-19 vaccine booster shot b Februar 10, 2022, which is one month after the start of spring classes, or 14 da s after

becoming eligible for a booster. is is an e tension of the <u>universit vaccine</u> <u>requirement polic</u>. Facult and sta ma upload updated vaccination information on the <u>AU Forward portal</u>. Individuals with an approved e emption from the COVID-19 vaccine requirement are also e empt from the booster requirement and should continue the required testing and other safet measures.

#### **Meetings**

Priorit will be given to academic research, student-related programs, alumni events, and admissions programming for in-person meetings. Regular facult or sta business meetings are encouraged to continue online to preserve campus space for student-focused activities. Given the vaccine requirements, facult, sta, and students can meet in small groups in o ces and schools/units can use their conference rooms for team meetings using best judgments to ensure safet.

#### **Guests and Visitors**

All guests/visitors to American Universit, including the AU campus, universit - owned or managed properties, or at an AU-sponsored event held o campus, must be full vaccinated.

Visitors must also be prepared to present their vaccination record card or a digital cop upon arrival on the AU campus, at universit -owned or managed properties, or at AU-sponsored events held o campus. All guests or visitors will follow applicable universit health and safet guidelines and abide b an additional measures outlined b the event coordinator or host and all posted signage.

Guests/visitors must check for COVID-19 s mptoms prior to coming to the AU campus, a universit -owned or managed propert, or an AU-sponsored event held o campus and not come to the event if e periencing s mptoms.

## Visitation in Residence Halls

Visitors una liated with AU (including famil members) are not allowed in residence halls during the spring 2022 semester.

#### Travel

An <u>interim travel approval process</u> is still in place for universit -authori ed, sponsored, or funded travel including Stud Abroad programs, timel or criticall needed facult and graduate-level research and grant-related travel, participation in dual-degree programs, travel for NCAA-sanctioned athletic competitions, admissions and recruitment activities, and individual sta travel required to carr out critical functions related to the AU mission.

e universit will review travel requests and make informed decisions regarding the risks posed b travel, particularl to destinations which ma not be safe due to local COVID-19 conditions. AU-authori ed or sponsored travel within the DMV region (Washington, DC/Mar land/Virginia) will not be applicable to the travel approval process. Additionall , personal travel plans not related to or sponsored b AU will also be e cluded from this process.
